Catholics and Jews in Twentieth-century America-Egal Feldman 2001 This book recounts the transformation of a relationship of irreconcilable enmity to one of respectful coexistence and constructive dialogue. From the Inquisition to the Passion Play at Oberammergau, the Catholic Church for centuries perpetuated a theology of contempt that reinforced antipathy between the two faiths. The interweaving of these various themes is what gives this work its ability to draw in readers—and will ultimately be what keeps the reader interested through the conclusion.
